

# 2024 OCTOBERFEST BUCKET RAFFLE TICKET INFORMATION

## WHAT DO I NEED TO KNOW?

- Hilltop Primary School PTA is doing a Bucket Raffle as part of the 2024 Octoberfest Fall Carnival on Saturday, October 12 from 11 a.m. – 3 p.m.
- A Bucket Raffle involves multiple prizes (see below) with each prize having its own bucket for the deposit of tickets based on the participant's choice. For example, if you're a HUGE Twins fan, put all your tickets in bucket #3! Or, spread your tickets across the buckets for a chance to win multiple prizes!
- Your child has been assigned 20 tickets to sell. Each ticket is only \$2.00!
- The bucket raffle drawings will take place on Saturday, October 12 at 3:00 PM in the Hilltop Cafeteria; a person does not need to be present to win.

## WHAT DO I NEED TO DO?

Step 1: Sell 20 Raffle Tickets

Step 2: Complete & Detach Ticket Stub with Adult Buyer Name & Phone #

Step 3: Circle Prize Bucket 1, 2, or 3 on Each Ticket Stub

Step 4: Return Ticket Stubs and Payment to Hilltop – Cash or Checks made out to Hilltop PTA  
(We CANNOT accept Venmo for raffle tickets)

Step 5: Return Unsold Tickets to Hilltop ASAP so another student may sell them
